IBM has firmly committed to Continuous Delivery since Db2 12. It is more important than ever to keep up with Function Level (FL). In the “good ol’ days”, it was possible to skip over some releases, but this will no longer be the case, as each FL builds upon the previous one. Any errors would only be multiplied.

The consequences for not paying close attention to each FL may not be immediately apparent as IBM no longer supports certain objects, but only tolerates them - until they don't! **This is now the case with deprecated features or functionalities that will block migration to Vnext.**

▣ **Migration HealthCheck** (MHC) is a light-weight “pocket tool”, specifically designed to assist with migrating between different levels of Db2 for z/OS by locating objects requiring attention. It provides a list of deprecated objects.

▣ **MigrationReadiness HealthCheck** (MRHC) is a light-weight and fast migration readiness checker for all objects within a Db2 sub-system or a Db2 data sharing group. It reports a set of KPIs about all objects and highlight those objects which are deprecated, incomplete or will block migration. Deprecated does not mean “gone”, it means “do not use as it might go in a future release.” The list of Migration Blockers are objects or definitions that will stop you migrating to Vnext. They were announced by Haakon Roberts at IDUG EMEA 2024 and John Lyle announced May 14th 2025 that IBM is actively working to convert remaining catalog and directory objects to UTS and more... **The Bottom Line : Be prepared! Run MRHC, write a road map and gradually do a few items a week from this list...**

**MHC comes as a licenced Freeware (reports deprecated objects) or a Full fee-based version that generates the required steps to migrate.**

**MRHC comes also as a licenced Freeware and a Full fee-based version that generates all DROPS, ALTERS, REORGs, RUNSTATS and REBINDs.**
